1. Remarks / Remarques

- a. After the introduction of the Parties, the Chamber directed that the proceedings be conducted in closed session to hear the evidence of Witness QCM from Kigali through a closed video link. Witness QCM was sworn in through a member of the Registry in Kigali. Prosecution Counsel (Ms. Maposa) conducted and finalized the examination-in-chief of Witness QCM (PW21). The Personal information sheet of Witness QCM was tendered as Prosecution Exhibit No. 27. Defence Counsel (Mr. Taylor) cross-examined Witness QCM (PW21) and thereafter, Prosecution Counsel (Ms. Maposa) re-examined Witness QCM (PW21). The Chamber subsequently discharged the witness.
- b. Defence Counsel (Mr. Taylor) made an oral application for extension of time to file his Rule 98 *bis* motion only on 15 August 2005. See the Chamber's Ruling below under paragraph 2.
- c. The session was adjourned to Monday 18 July 2005 at 10.00 a.m. when the Chamber will hear the evidence of witness NN by video-link from the Hague.
