1. Remarks / Remarques

- a. Ken Fleming, Senior Trial Attorney made an oral motion on the admissibility of documentary evidence. He referred to incidences where the Defence referred to two witness statements and transcripts of previous trial without reading in record or tendering the documents. He requested the Chamber to receive the statement made by Witness GHA. The Defence objected to the admissibility of the statement.
- b. The Chamber directed the parties to make available to the bench all documents they intended to use and to give accurate citations. The Chamber informed the parties that further directives would be given after deliberation.
- c. Prosecution Counsel Melinda Pollard conducted the examination-in-chief of PW 4: GGY.
- d. Co-counsel Feargal Kavanagh requested the Chamber to direct the Prosecutor to furnish the Defence with the notes she took at the time of preparing witness GGY. The Prosecutor objected on the ground of protected information.
- e. The Chamber denied the Defence's request.
- f. Co-counsel Feargal Kavanagh commenced the cross-examination of PW 4: GGY.
- g. The proceedings were adjourned to 15 August 2002 at 9.00 hours.
